5. Record receipt of Submission of 2019 Tax Year Appraisal Roll and New Property Value for the District and authorize any necessary action;
6. Record Certification of 2019 Tax Year Anticipated Collection Rate and authorize any necessary action;
7. Record Certification of 2019 Appraisal Roll and authorize any necessary action;
8. Approve annual 10/20 Year Write Off Of Property Taxes;
9. Adopt Resolution Voting for Water District Nominee for the Election of the Board of Directors of the Fort Bend Central Appraisal District;
10. Adopt Resolution Recommending a Candidate for a Position on the Board of Directors of the Gulf Coast Water Authority;
11. General Manager's Report including water and wastewater system operation, Industrial User Pretreatment Program and District operations;
12. Approve Director's per diem;

13. District operations, including but not limited to; Administrative, Field Service, Wastewater and Surface Water Treatment Plants, general operational tasks and authorize any necessary action;
