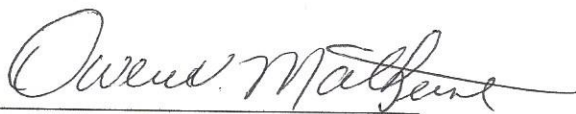

Notice is hereby given that the Board of Directors of Fort Bend County Water Control and Improvement District No. 2, of Fort Bend and Harris Counties, Texas, will hold a Regular Meeting, open to the public, on Wednesday the 28<sup>th</sup> day of September, 2016, at 6:00 p.m., at the District Office, 2331 South Main, Stafford, Texas, within the boundaries of the District, for the following purposes:

1. Call meeting to order;
2. Pledge of Allegiance to the Flag of our Country and State;
3. Conduct Public Hearing regarding District's tax rate, adopt Order Levying Taxes, and authorize execution of Amendment to Information Form;
4. Audience comments; Comments from the audience (for matters not on the agenda) – This provides an opportunity to comment on non-agenda items in advance of the regular business of the Board of Directors. Comments shall be limited to three (3) minutes per person. By state law, comments by the President or Board members on any item not on the agenda shall be limited to;
  - a. Statements of specific factual information given in response to any inquiry;
  - b. A recitation of existing policy in response to an inquiry;
  - c. A proposal to place the subject on the agenda for a future meeting;
5. Engage auditor to conduct audit for fiscal year end September 30, 2016;
6. Update on Demand Response Program and authorize any necessary action;
7. Review quote for purchase of equipment and authorize any necessary action;
8. General Manager's Report, including: water and wastewater system operation, Industrial Users Pretreatment Program;
  - a. Backflow test report compliance disconnect notices;
9. Engineer's Report, including status of the following District projects and authorizes any necessary action;
  - a. Ave. E & U.S. 90A Commercial Development Utilities;
  - b. Brand Lane Water Plant Connection;
  - c. Utilities for the Stafford Groves Development 59 & W. Airport;
  - d. Water and Sanitary Public Utility for Park 8 Ninety Developments;
  - e. Public Water Utilities for Cravens Road sanitary sewer relocation 2015;
  - f. Lift Station No. 6 Expansion;
  - g. Surface Water Treatment Plant transmission lines;
  - h. WWTP Non-potable system;
  - i. Sub-division utility rehabilitation and development issues;
  - j. Sludge Processing Modifications;

k. General Engineering, development plats, consent to encroach agreements, facilities, annexation and development issues;

10. Discuss write-offs of customer's accounts and authorize any necessary action;
11. Review and discuss the Financial Statement for August 2016 and authorize any necessary action;
12. Approve payment of District expenditures;
13. Review, discuss and adopt budget for fiscal year ending September 30<sup>th</sup>, 2017 and authorize any necessary action;
14. Acquisition of real estate for water plant facilities;
15. Request for future agenda items;
16. Update on District operations and authorize any necessary action;

Convene Executive Session pursuant to Section 551.076, Texas Government Code to deliberate the deployment or specific occasions for implementation of security personnel or devices; pursuant to Section 551.087 of the Texas Government Code to deliberate possible economic development negotiations with a business prospect; pursuant to Section 551.072 to discuss acquisition and disposition of real estate; pursuant to Section 551.074 of the Texas Government Code, to deliberate the appointment, employment, evaluation, reassignment, duties, discipline, or dismissal of a public officer or employee;
18. Reconvene in Open Session and authorize action regarding personnel, security, economic development, and/or real estate matters discussed in Executive Session;
