Notice is hereby given that the Board of Directors of Fort Bend County Water Control and Improvement District No. 2, of Fort Bend and Harris Counties, Texas, will hold a Regular Meeting, open to the public, on Wednesday the 14 day of November, 2018, at 6:30 p.m., at the District Office, 2331 South Main, Stafford, Texas, within the boundaries of the District, for the following purposes:

1. Call meeting to order;
2. Pledge of Allegiance to the Flag of our Country and State;
3. Audience comments; Comments from the audience (for matters not on the agenda) – This provides an opportunity to comment on non-agenda items in advance of the regular business of the Board of Directors. Comments shall be limited to three (3) minutes per person. By state law, comments by the President or Board members on any item not on the agenda shall be limited to;
 - a. Statements of specific factual information given in response to any inquiry;
 - b. A recitation of existing policy in response to an inquiry;
 - c. A proposal to place the subject on the agenda for a future meeting.
4. Approve Board meeting minutes of October 24, 2018;
5. \$39,500,000 Unlimited Tax Bonds, Series 2019, including approve bond sale schedule, authorize preparation of preliminary official statement and official notice of sale, adopt Resolution Requesting Appraisal of Property and Certificate of Estimated Appraised Value; and authorize district engineer to request Texas Commission on Environmental Quality inspection of facilities;
6. Update on Fountain Head Mobile Home Park and authorize any necessary action;
7. Engineer's Report, including status of the following District projects and authorize any necessary action;
 - a. Lift Station No. 19 Rehab;
 - b. Miscellaneous development repair and improvement projects;
 - c. General Engineering, development plats, consent to encroach agreements, facilities, annexations and development issues;
8. General Manager's Report, including: water and wastewater system operation, Industrial Users Pretreatment Program, and District operations;
9. Review and discuss the Financial Statement for October 2018 and authorize any necessary action;
10. Travel Reimbursement Guidelines and Director Expenses for the Association of Water Board Directors winter conference;
11. Approve payment of Director's per diem;
12. Approve payment of District expenditures;

- 13. District operations, including but not limited to; Administrative, Field Service, Wastewater and Surface Water Treatment Plants, general operational tasks and authorize any necessary action;
