Notice is hereby given that the Board of Directors of Fort Bend County Water Control and Improvement District No. 2, of Fort Bend and Harris Counties, Texas, will hold a Regular Meeting, open to the public, on Wednesday the 19 day of September, 2018, at 6:30 p.m., at the District Office, 2331 South Main, Stafford, Texas, within the boundaries of the District, for the following purposes:

 - b. A recitation of existing policy in response to an inquiry;
 - c. A proposal to place the subject on the agenda for a future meeting.
- 4. Conduct public hearing regarding District's tax rate, adopt Order Levying Taxes, and authorize execution of Amendment to Information Form;
- 5. Conduct public hearing regarding Defined Area tax rate, adopt Order Levying Taxes, and authorize execution of Amendment to Information Form;
- 6. Approve Board meeting minutes of August 22, 2018;
- 7. Review 2018-2019 General Liability insurance renewal and authorize any necessary action;
- 8. Engage McGrath & Co., PLLC to prepare the District's audit for the year end September 30, 2018:
- 9. Approve Amendment to Residential Solid Waste Collection and Disposal Contract with Waste Corporation of Texas;
- 10. Adopt Amended Rate Order;
- 11. Approve Fifth Amendment to Wholesale Water Service Agreement with Harris County Municipal Utility District No. 122;
