- 5. Approve Agreement to Terminate Emergency Water Interconnect Agreement with City of Meadows Place;**
- 6. Authorize execution of General Certificate in connection with East Fort Bend Development Authority Defined Area Contract Revenue Bonds;**
- 7. General Manager's Report including water and wastewater system operations, Industrial User Pretreatment Program and District operations and water and sewer service payment options;**
- 8. Approve payment of Director's per diem;**
