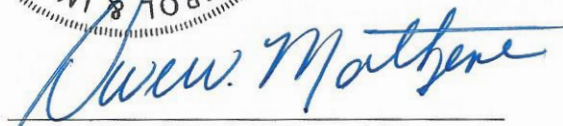

Notice is hereby given that the Board of Directors of Fort Bend County Water Control and Improvement District No. 2, of Fort Bend and Harris Counties, Texas, will hold a Regular Meeting, open to the public, on Wednesday the 24th day of May 2023, at 6:30 p.m., at the District Office, 2331 South Main, Stafford, Texas, within the boundaries of the District, for the following purposes:

1. Call meeting to order;
2. Pledge of Allegiance to the Flag of our Country and State;
3. Audience comments. Comments from the audience (for matters not on the agenda). This provides an opportunity to comment on non-agenda items in advance of the regular business of the Board of Directors. Comments shall be limited to three (3) minutes per person. By state law, comments by the President or Board members on any item not on the agenda shall be limited to:
 - a. Statement of specific factual information given in response to any inquiry;
 - b. A recitation of existing policy in response to any inquiry;
 - c. A proposal to place the subject on the agenda for a future meeting;
4. Approve Board meeting minutes of April 26, 2023;
5. Approve General Certificate for the East Ford Bend County Development Authority Series 2023 Contract Revenue Road Bonds;
6. Approve Consumer Confidence Report and authorize staff to mail Consumer Confidence Report and file certificate of mailing with the Texas Commission on Environmental Quality;
7. Acceptance of Kirkwood Industrial utility improvements;
8. Acceptance of City Park Drive utility improvements;
9. Review quotes for repairs to primary clarifier No. 2, and WWTP No. 1 rehabilitation project and authorize any necessary action;

10. Review and discuss draft Newsletter and authorize any necessary action;
11. Engineer's Report, including status of the following District projects and authorize any necessary action;
 - a. Brand Lane Water Plant Generator Replacement;
 - b. Miscellaneous development repair and improvement projects;
 - c. General Engineering, development plats, consent to encroach agreements, easements, facilities, annexations, and development issues.
12. General Manager's Report including Water and Wastewater System Operations, and the Industrial Pretreatment Program;
