Notice is hereby given that the Board of Directors of Fort Bend County Water Control and Improvement District No. 2, of Fort Bend and Harris Counties, Texas, will hold a Regular Meeting, open to the public, on Wednesday the 26th day of June 2024, at 6:30 p.m., at the District Office, 2331 South Main, Stafford, Texas, within the boundaries of the District, for the following purposes:

 - b. A recitation of existing policy in response to any inquiry;
 - c. A proposal to place the subject on the agenda for a future meeting;
- 4. Approve Board meeting minutes of June 12, 2024;
- 5. Discuss Association of Water Board Directors summer conference, approve reimbursement of eligible expenses, and authorize attendance at winter conference;
- 6. Adopt Resolution Regarding Development Status for 2024 Tax Year
- 7. Review and discuss the Gulf Coast Water Authority Application for Crossing Agreement for the eight-inch waterline extension from Staffordshire Road to Moore Road and authorize any necessary action;
- 8. Engineer's Report, including status of the following District projects and authorize any necessary action.
 - a. Surface Water Treatment Plant Expansion to 7.8 MGD Phase II;
 - b. Texas Instruments Multifamily Phase III Sanitary Sewer Extension Utility Construction Conveyance Agreement
 - c. Pike Road 12-inch Waterline Extension Utility Construction Conveyance Agreement
 - d. Murphy Road & Greenbriar Road Sanitary Sewer Rehabilitation Phase 1

- e. Miscellaneous development repair and improvement projects;
- f. General Engineering, development plats, consent to encroach agreements, easements, facilities, annexations, and development issues.
- 9. Review and discuss Financial Statement for May 2024 and authorize any necessary action.
- 10. Approve District expenditures.
- 11. District operations, including but not limited to; Administrative, Field Service, Wastewater and Surface Water Treatment Plants, and general operational tasks and authorize any necessary action.
