Notice is hereby given that the Board of Directors of Fort Bend County Water Control and Improvement District No. 2, of Fort Bend and Harris Counties, Texas, will hold a Regular Meeting, open to the public, on Wednesday the 28th day of August 2024, at 6:30 p.m., at the District Office, 2331 South Main, Stafford, Texas, within the boundaries of the District, for the following purposes:

 - b. A recitation of existing policy in response to any inquiry;
 - c. Proposal to place the subject on the agenda for a future meeting;
4. Approve Board meeting minutes of August 14, 2024;
5. Review and discuss Bond Series 2024 and authorize any necessary action.
 - a. Approve Preliminary Official Statement and Official Notice of Sale.
 - b. Engage rating company to perform credit rating analysis for Series 2024A Unlimited Tax Bonds.
 - c. Appoint Paying Agent/Registrar.
 - d. Authorize advertisement for sale of the Series 2024A Bonds and schedule bond sale.
6. Engineer's Report, including status of the following District projects and authorize any necessary action.
 - a. Surface Water Treatment Plant Expansion to 7.8 MGD Phase II;
 - b. Staffordshire Road Waterline Extension;
 - c. Murphy Road & Greenbriar Road Sanitary Sewer Rehabilitation Phase I;
 - d. Wastewater Treatment Plant No. 1 Improvements;
 - e. Miscellaneous development repair and improvement projects;

- f. General Engineering, development plats, consent to encroach agreements, easements, facilities, annexations, and development issues.
7. Renewal of District's general liability insurance policies and authorize any necessary action;
8. Renewal of District's medical insurance policy and authorize any necessary action;
9. Review and discuss Financial Statement for July 2024 and authorize any necessary action.
10. Update on Human Resources and authorize any necessary action;
11. Approve District expenditures.
