4. Approve Board meeting minutes of August 28, 2024;
5. Review and discuss District's Murphy Road Water Line Extension project and authorize any necessary action;
 - a. Discuss appraisal value and approve compensation to Realty Income for Easement;
 - b. Discuss and authorize approval of construction plans and publication for the submission of bids;
6. Discuss 2024 tax rate for District and Defined Area, set public hearings date, and authorize notices of public hearing regarding adoption of tax rates;
7. Engage auditor to conduct audit for fiscal year end September 30, 2024;
8. Review budget for fiscal year end September 30, 2025 and authorize any necessary action;
9. General Manager's Report including Water and Wastewater System Operations, and the Industrial Pretreatment Program;
