5. Engineer's Report, including status of the following District projects and authorize any necessary action;
 - a. Surface Water Treatment Plant Expansion;
 - b. Staffordshire Waterline Extension to Independence;
 - c. Murphy Road & Greenbriar Road Sanitary Sewer Rehabilitation Phase 1 - Cleaning & Televising;
 - d. Wastewater Treatment Plant No. 1 Improvements;
 - e. Miscellaneous development repair and improvement projects;
 - f. General Engineering, development plats, consent to encroach agreements, easements, facilities, annexations, and development issues.
6. Discuss District's safety program and authorize any necessary action;
7. Review and discuss Financial Statement for August 2024 and authorize any necessary action;
