



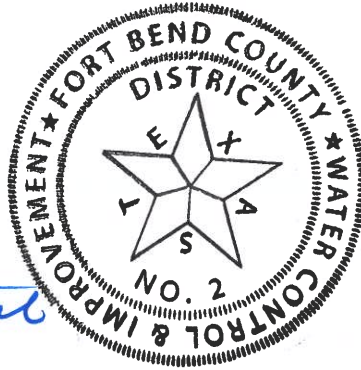
**NOTICE OF REGULAR MEETING

Notice is hereby given that the Board of Directors of Fort Bend County Water Control and Improvement District No. 2, of Fort Bend and Harris Counties, Texas, will hold a Regular Meeting, open to the public, on Wednesday the 20th day of August 2025, at 6:30 p.m., at the District Office, 2331 South Main, Stafford, Texas, within the boundaries of the District, for the following purposes:

1. Call meeting to order.
2. Pledge of Allegiance to the Flag of our Country and State.
3. Audience comments. Comments from the audience (for matters not on the agenda). This provides an opportunity to comment on non-agenda items in advance of the regular business of the Board of Directors. Comments shall be limited to three (3) minutes per person. By state law, comments by the President or Board members on any item not on the agenda shall be limited to:
 - a. Statement of specific factual information given in response to any inquiry;
 - b. A recitation of existing policy in response to any inquiry;
 - c. Proposal to place the subject on the agenda for a future meeting.
4. Approve Board meeting minutes of July 23, 2025.
5. Adopt Resolution Nominating Candidate for Board of Director Election for Harris Central Appraisal District.
6. Engineer's Report, including status of the following District projects and authorize any necessary action.
 - a. Surface Water Treatment Plant Expansion to 7.8 MGD Phase II;
 - b. Staffordshire Road Waterline Extension;
 - c. MW Industrial 8-inch Waterline Extension Murphy Road;
 - d. Manhole Rehabilitation;
 - e. Wastewater Treatment Plant No. 1 Improvements;
 - f. Miscellaneous development repair and improvement projects;
 - g. General Engineering, development plats, consent to encroach agreements, easements, facilities, annexations, and development issues.
7. Renewal of District's medical insurance policy and authorize any necessary action.
8. Review and discuss Financial Statement for July 2025 and authorize any necessary action.
9. Approve District expenditures.

10. General Manager's Report including Water and Wastewater System Operations, and the Industrial Pretreatment Program.
11. District operations, including but not limited to; Administrative, Field Service, Wastewater and Surface Water Treatment Plants, and general operational tasks and authorize any necessary action.
12. Future agenda items.
