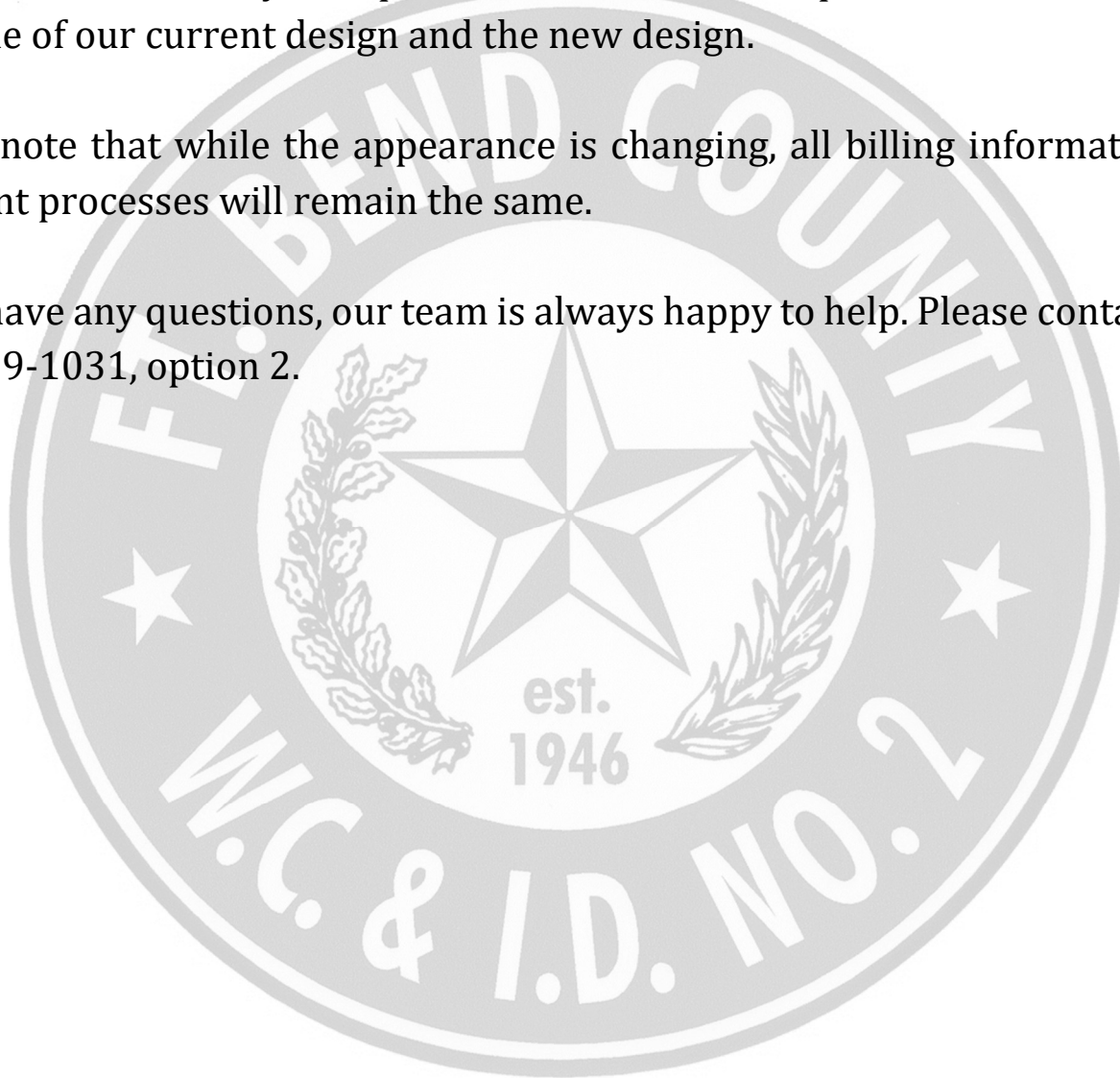


NEW INVOICE LOOK


Please note that while the appearance is changing, all billing information and payment processes will remain the same.
